SUBMISSION OF AGREED PROCEDURAL SCHEDULE

Northern Indiana Public Service Company ("NIPSCO"), by counsel, respectfully submits a proposed procedural schedule in this Cause, consistent with the Commission's General Administrative Order 2013-5 (Rate Case Standard Procedural Schedule and Recommended Best Practices for Rate Cases Submitted

under Ind. Code § 8-1-2-42.7) ("GAO 2013-5").

Prior to filing, NIPSCO discussed the 300-day schedule with the Indiana Office of Utility Consumer Counselor ("OUCC") and other interested stakeholders.¹ Based upon feedback from those stakeholders, NIPSCO is proposing certain revisions to the specific dates that would be set based upon GAO 2013-5. The OUCC, Citizens Action Coalition of Indiana, Inc. ("CAC"), Indiana Municipal Utilities Group ("IMUG"), NLMK Indiana ("NLMK"), NIPSCO Industrial Group and United States Steel Corporation ("U.S. Steel") have all advised they do not object to the proposed schedule.
