# REBUTTAL TESTIMONY OF ANDREW S. RITCH WHOLESALE RENEWABLES MANAGER DUKE ENERGY BUSINESS SERVICES LLC ON BEHALF OF DUKE ENERGY INDIANA, LLC BEFORE THE INDIANA UTILITY REGULATORY COMMISSION

1		I. <u>INTRODUCTION</u>
2	Q.	PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.
3	A.	My name is Andrew S. Ritch and my business address is 139 E. 4 <sup>th</sup> Street, Cincinnati,
4		Ohio 45202.
5	Q.	ARE YOU THE SAME ANDREW S. RITCH WHO PROVIDED DIRECT
6		TESTIMONY IN THIS PROCEEDING?
7	A.	Yes, I am.
8	Q.	WHAT IS THE PURPOSE OF YOUR TESTIMONY?
9	A.	The purpose of my testimony is to respond to the testimony filed by the Indiana Office of
10		Consumer Counselor ("OUCC"), Walmart Inc. and the Citizens Action Coalition, Inc.
11		("CAC"). Specifically, I will address the claims made by the OUCC that the Company's
12		proposed Solar Services Program is vague and confusing, and that Duke Energy Indiana
13		has failed to meet its burden of proof in seeking approval for this voluntary solar option
14		for our customers. In response to Walmart's and the CAC's testimony, I will explain and
15		clarify the Company's plan for the renewable attributes associated with the solar facilities
16		constructed under this program, and will sponsor the revised tariff and customer service
17		agreement that also make plain what will be done with the renewable attributes. Finally,

1		I will address the additional points raised by Mr. Olson in his testimony on behalf of
2		CAC.
3	Q.	HAVE YOU REVIEWED THE TESTIMONY OF THE OUCC IN THIS
4		PROCEEDING?
5	A.	Yes, I have.
6	Q.	BEFORE YOU BEGIN YOUR SPECIFIC REBUTTAL, COULD YOU PLEASE
7		DESCRIBE DUKE ENERGY INDIANA'S OVERALL REACTION TO THE
8		OUCC'S TESTIMONY?
9	A.	Yes. Duke Energy Indiana was surprised and disappointed by the OUCC's testimony in
10		this proceeding. The Company proposed its solar services tariff only after discussions
11		with its' customers, a two-year collaborative process as part of the 2016 Edwardsport
12		Settlement Agreement (in which the OUCC participated), and after multiple meetings
13		with solar developers presently active in Indiana. Additionally, Duke Energy Indiana
14		worked with the OUCC after its filing to clarify its proposed program, and to revise its
15		tariff and service agreement to address the OUCC's concerns.
16		We discussed this program with solar developers which were universally excited
17		about the prospect of partnering with Duke Energy Indiana under this proposed tariff and
18		viewed our proposal as another option for customers to finance the solar facilities they
19		are already offering to and constructing for customers across our service territory. They
20		certainly did not view the proposed tariff as an "unregulated monopoly" or "unfair
21		competition," as alleged by the OUCC.

Our proposal is simply a voluntary option for eligible Duke Energy Indiana customers to use for financing, constructing, operating and maintaining a solar energy facility on their premises. Under the service agreement, customers will be able to receive the benefits of renewable energy without the financial risk associated with facility performance and maintenance.

Duke Energy Indiana finds it unfortunate, despite repeated attempts to provide clarity, that the OUCC would contend that Duke Energy Indiana has not been fully transparent with its proposed program. We disagree.

It was my understanding that the issues the OUCC had raised during our discussions would be both simple and easy to resolve. First, the OUCC wanted the Company to make clear the treatment of the renewable attributes associated with any solar facility constructed under this proposed tariff: a good point and one to which the Company readily agreed in our discussions.

Second, the OUCC questioned how customers participating in the Company's proposed tariff could participate in net metering without owning and operating the solar facilities constructed under this proposed tariff. Duke Energy Indiana explained that the Company already has the flexibility to offer net metering to customers not meeting all the conditions listed in its net metering tariff on a case by case basis, at its discretion. As an example, the Company has used this flexibility in the past to allow a church to participate in net metering even through that church did not own and operate the solar facility itself, but rather created an LLC for that purpose. This is the same common-sense approach the

Company would bring to administering this proposed tariff, as well. We expect schools and other nonprofit entities to be the most interested in this proposed tariff and believe providing exceptions to allow such a limited group of customers to participate in net metering to be reasonable and in the public interest.

In addition, the Company filed this proposed program with the Commission for the purposes of obtaining its review and approval – both the Company's existing net metering tariff and approval (if obtained) in this proceeding give the Duke Energy Indiana the ability to provide some flexibility to a small number of our customers who are interested in pursuing the construction of solar facilities on their premises to also participate in net metering.

Third, the OUCC expressed an interest in understanding how the Company intended to ensure that this proposed program not be subsidized by non-participating customers. We also believed that to be a reasonable question and provided the agency information regarding the checks and balances put in place by Duke Energy Indiana to make sure that all program costs are borne solely by program participants. These types of controls are used by the Company every day to make certain the costs of service are charged to the correct customers and customer classes. As detailed below, Duke Energy Indiana is willing to report back to the Commission on this issue as the program proceeds for additional oversight.

This proposed tariff is voluntary – participation is limited to larger commercial customers and those interested customers must be willing: 1) to have solar generating

1		facilities constructed on their property; 2) to pay for the construction, operation and			
2		maintenance of such solar generating facilities and 3) sign a service agreement to			
3		participate in this tariff offering. I find the fact that the OUCC would file testimony,			
4		seemingly vehemently opposed to a completely voluntary program designed to modestly			
5		expand distributed solar generation in the state of Indiana in a way that minimally, if at			
6		all, impacts the Company's non-participating customers to be rather inexplicable. My			
7		rebuttal testimony will specifically respond to the OUCC's testimony in more detail			
8		below.			
9		II. PROPOSED TREATMENT OF RENEWABLE ATTRIBUTES			
10	Q.	ARE YOU FAMILIAR WITH THE TESTIMONY FROM MR. TILLMAN ON			
11		BEHALF OF WALMART?			
12	A.	Yes, I am.			
13	Q.	ARE YOU ALSO FAMILIAR WITH THE TESTIMONY FROM MR. OLSON ON			
14		BEHALF OF THE CITIZENS ACTION COALITION ("CAC")?			
15	A.	Yes, I am.			
16	Q.	COULD YOU PLEASE BRIEFLY DESCRIBE THE POSITION OF WALMART			
17		AND CAC REGARDING RENEWABLE ATTRIBUTES GENERATED UNDER			
18		THIS PROGRAM?			
19	A.	Yes. Both parties expressed an interesting in having any renewable attributes associated			
20		with solar facilities constructed under this tariff be either retired or granted to the			
21		participating customer.			

1	Q.	IS THE COMPANY WILLING TO MODIFY ITS PROPOSED TREATMENT OF
2		THE RENEWABLE ATTRIBUTES ASSOCIATED WITH SOLAR FACILITIES
3		CONSTRUCTED UNDER THIS TARIFF?
4	A.	Yes, the Company is willing to change its proposal. Duke Energy Indiana had initially
5		intended to retain the renewable attributes or renewable energy credits ("RECs")
6		associated with the solar facilities constructed unless the participating customer expressed
7		an interest in obtaining the renewable attributes itself. The reason that the Company had
8		intended to keep the renewable attributes was simply because the Company would be
9		owning the solar facilities through the term of the solar service agreement, and would
10		have the option of selling those RECs to benefit all customers, unless the specific solar
11		customer wanted the RECs
12		After hearing from Walmart and the CAC, the Company understands those parties
13		(as well as the OUCC) would prefer that Duke Energy Indiana give any renewable
14		attributes to the participating customer or retire them on the customer's behalf, and to
15		specify that treatment in the tariff and service agreement. We think the simplest solution
16		is to give the RECs to participating customers and agree to make that change to our
17		proposed program. Petitioner's Exhibit 2-A is a revised tariff and Petitioner's Exhibit 2-
18		B is a revised service agreement, which both indicate participating customers will receive
19		the renewable attributes associated with their solar facilities.
20		III. PROPOSED CHANGES AND CLARIFICATIONS
21	Q.	IS DUKE ENERGY INDIANA NOW PROPOSING THE COMMISSION ADOPT

1		CERTAIN REPORTING REQUIREMENTS FOR ITS SOLAR PROGRAM?			
2	A.	Yes. After internal conversations, as well as in response to OUCC's testimony alleging			
3		that this proposed program would be unregulated, Duke Energy Indiana is proposing to			
4		comply with the following annual reporting requirements:			
5		1. Number of participating customers			
6		2. Number of new customers since the last submittal			
7		3. Effective date of each new service agreement			
8		4. Electric Tariff rate each participating customer is served under			
9		5. Revenues and expenses to the Company from this program			
10	Q.	PLEASE EXPLAIN IN MORE DETAIL WHY THE COMPANY IS PROPOSING			
11		THESE ANNUAL REPORTS.			
12	A.	Duke Energy Indiana is proposing to submit annual reports to the Commission to help			
13		alleviate any concerns about the operation of this proposed program. We want the			
14		Commission to have full access to information regarding the program, to be able to ask			
15		questions, and to be assured that other Duke Energy Indiana customers are not			
16		subsidizing this program in any way. Duke Energy Indiana has not sought an alternative			
17		regulatory plan for this proposed tariff as a means of avoiding regulatory oversight, but			
18		instead seeks only to eliminate the need to file separate approval requests for each solar			
19		facility constructed under this tariff and to allow the Company to charge going market			
20	rates for the services provided under the service agreement.				
21	Q.	IS DUKE ENERGY INDIANA ALSO PROPOSING TO TREAT THE PROPOSED			

1		SULAR PRUGRAM AS A PILUI!			
2	A.	Yes. Also in an attempt to alleviate concerns about the proposed program, Duke Energy			
3		Indiana is proposing to treat it as a pilot program and to return to the Commission when			
4		the Company has participating customers with systems equaling 10 MW in the aggregate,			
5		or five years, whichever happens sooner. This proposal helps to ensure continued			
6		Commission oversight of this proposed pilot, as well as a broader conversation occurs			
7		about the interest of Indiana businesses and nonprofit entities in sponsoring solar			
8		facilities on their premises.			
9	Q.	HAS THE COMPANY MADE ANY OTHER CHANGES TO ITS TARIFF OR			
10		SERVICE AGREEMENT IN RESPONSE TO THE POSITIONS OF THE			
11		STAKEHOLDERS IN THIS PROCEEDING?			
12	A.	Yes. In response to the OUCC's request, Duke Energy Indiana has specifically stated in			
13		the tariff that participation will be limited to 10 MW nameplate capacity and that			
14		participants may also participate in the Company's net metering tariff, subject to			
15		applicable law (such as Indiana Code 8-1-40-13).			
16	Q.	BOTH THE OUCC AND MR. OLSON EXPRESS A CONCERN ABOUT THE			
17		COMPANY'S PLANS FOR BILLING PARTICIPATING CUSTOMERS UNDER			
18		THIS PROGRAM. COULD YOU PLEASE PROVIDE ADDITIONAL			
19		EXPLANATION OF THE COMPANY'S PLANS IN THIS REGARD?			
20	A.	Yes. Duke Energy Indiana will be manually producing a separate and additional bill for			
21		participating customers that will include the cost under the service agreement.			

1		Participating customers will also receive their normal bill for electric service. The			
2		Company is presently investing in a new customer information system that may, in			
3		several years, be able to produce just one bill for both electric service and service under			
4		this voluntary tariff. Should our participating customers have an interest in receiving just			
5		one bill for both services, the Company would make that option available to them.			
6		Should customers prefer to continue to receive separate bills, that option will also be			
7		available. Duke Energy Indiana will continue to share information about its new			
8		customer information system and any future changes to customer bills with the			
9		Commission and interested stakeholders. As for the foreseeable future, however,			
10		participating customers will receive two bills.			
11		IV. <u>DUKE ENERGY INDIANA RESPONSE TO OUCC CONCERNS</u>			
12	Q.	THE OUCC STATES THAT THIS PROPOSAL OFFERS FINANCIAL AND			
13		PUBLIC RELATIONS BENEFITS TO DUKE ENERGY INDIANA AND A FEW			
14		SELECT CUSTOMERS AT THE EXPENSE OF OTHER RATEPAYERS. DO			
15		YOU AGREE WITH THIS STATEMENT?			
16	A.	No, I do not. Duke Energy Indiana is proposing this program in response to interest from			
17		our customers in greater options for cleaner energy. This Commission, and I'm sure the			
18		OUCC as well, is aware of school districts installing solar panels on their rooftops,			
19		Cummins, Inc.'s wind purchased power agreement, and various cities and towns across			
20		the state investing in renewable energy. The Company already offers Go Green, another			
21		voluntary tariff, under which customers may purchase RECs, and would like to provide			

interested customers another voluntary program that provides them the ability to meet their renewable and sustainability goals through a tangible, visible solar system that it located on their premises.

Duke Energy Indiana believes the public interest is indeed served by the offering of this program. Eligible customers who may have already been considering the installation of a solar facility would have another option to finance the facility. Should the benefits associated with the Company's proposed service agreement be attractive to those customers, those customers would benefit from participating. Should the customer determine the benefits do not justify the expense, the customer is under no obligation to proceed with participating under this program and their standing as a Duke Energy Indiana customer and resulting electric service will not be affected. Duke Energy Indiana benefits from this program by continuing to be seen as a valued partner committed to serving our customers and meeting their needs.

Non-participating customers are not impacted by this program, but for the subsidy already inherent in net metering – which the legislature has already addressed through the enactment of SEA 309, which contains a gradual phase-out of this subsidy. The Commission and other stakeholders benefit by learning more about the level of interest in this offering amongst participating customers, in addition to the benefits of the partnerships formed in this industry that will promote continued expansion of the solar energy industry in the state. Duke Energy Indiana intends to engage independent third party solar developers to construct, operate and maintain these facilities for participating

customers, thus creating jobs and impacting the local economy. Finally, the Commission becomes involved with the installations of solar facilities on customer premises – an area with much activity and little to no current Commission oversight. Contrary to the OUCC's argument that Duke Energy Indiana somehow would become an "unregulated monopoly" should the Commission approve this pilot program, Duke Energy Indiana will, of course, remain a public utility, subject to the Commission's oversight and regulatory authority.

Q.

Further, customers may voluntarily participate in this program should it prove attractive to them. If the terms of the service agreement prove to be unattractive, those customers may choose to build their solar with a different vendor and self-finance their investment or choose another path entirely. Not only will this program be regulated, but it will not be a monopoly. Customers already have other choices to construct solar facilities on their property – this program is simply one more choice for those customers.

Duke Energy Indiana's attached summary net metering report demonstrates the vast interest and market that exists for customers to install solar on their premise. See Petitioner's Exhibit 2-C. This voluntary option is just one more approach. Duke Energy Indiana submits that this pilot program does, in fact, serve the public interest and should be approved for its initial term.

THE OUCC'S TESTIMONY SUGGESTS THAT THE PROPOSED SOLAR
SERVICES TARIFF WOULD HAVE NO REGULATORY PROTECTIONS FOR
CONSUMERS. IS THIS CORRECT?

No. There is no support for such a misleading claim. As I mentioned above, Duke Energy Indiana is proposing to and will remain a public utility under Indiana law, subject to the regulatory oversight of the Commission. The fact that this statement was made by the OUCC in the context of a docketed regulatory proceeding in which the Company is asking the Commission to approve this tariff serves to underscore how misleading it is.

A.

The exceptions sought by the Company under its proposed alternative regulatory plan are narrow and limited: 1) for Duke Energy Indiana to be able to construct solar facilities for a limited number of participating customers without filing additional proceedings; and 2) for Duke Energy Indiana to be able to offer this service to customers at market-based rates, tailored to the size and other needs of each specific customer.

Duke Energy Indiana will remain subject to Commission oversight in all other manners and forms. For example, should a customer be participating in this tariff and have an issue with its billing or the performance or maintenance of its solar facilities, that customer could file a complaint at the Commission. The proposed reporting requirements and limited initial term of the pilot offering also ensure continued Commission oversight and jurisdiction.

Consider whether a net metering customer today could complain to the Commission about the performance or maintenance of the solar panels on its rooftop that were installed by a third-party developer. They could not. Duke Energy Indiana believes that Commission oversight over this program is an important consumer protection – and is certainly not some sort of unfair competitive advantage to Duke Energy Indiana over

other solar developers.

# Q. IS THIS PROPOSED TARIFF AN UNFAIR MEANS OF COMPETING WITH OTHER SOLAR DEVELOPERS IN THE STATE?

No, it is not. The Company believes its proposal increases competition, which provides direct benefits to solar developers and customers alike. As I stated in my direct testimony, Duke Energy Indiana has met with numerous solar developers and they do not view this offering an unfair competition, but instead welcome the possibility of partnering with a public utility to expand solar in Indiana. The solar development community understands that Duke Energy Indiana's proposed tariff represents an additional tool for them to use in their sales pitches to customers – not only can the developer construct the facility for the customer, they could also operate and maintain the facility, all of which is backed by Duke Energy Indiana, an entity that will enter into a service agreement with these customers.

Duke Energy Indiana also provides comfort to the customer of being a regulated public utility – and solar developers understand that our involvement may help a school district or university be more willing to invest in solar than they otherwise would. As stated previously, I have attached two letters of support from Indiana solar developers, as Petitioner's Exhibit 2-D and 2-E, explaining that they welcome our involvement, are interested in partnering with us under this program and do not share the OUCC's concerns about unfair competition.

#### 21 Q. WHAT EFFORTS HAS THE COMPANY MADE TO CREATE A

#### COMPETITIVE MARKET THROUGH THIS OFFERING? 1 2 As stated in my direct testimony, Duke Energy Indiana will not use any affiliates of its A. 3 parent, Duke Energy Corporation, to construct these facilities (another change that developed during the Edwardsport collaborative discussions). Instead, based on the 4 5 preference of each customer, the Company will competitively bid out construction of the 6 facility. To this means, the Company issued a Request for Information ("RFI") on 7 November 2, 2018, and has already begun reviewing the qualifications of solar 8 developers through the information it received. The RFI was issued to the regional solar 9 development community, and included a list of developer contacts from the CAC. The 10 Company will formally announce its preferred vendors should this proposal be approved. 11 Q. THE OUCC'S TESTIMONY SEEMED TO INDICATE THAT CUSTOMERS 12 PARTICIPATING IN THIS PROGRAM WOULD RECEIVE ENHANCED OR 13 DIFFERENT NET METERING BENEFITS THAN NON-PARTICIPATING 14 **CUSTOMERS. IS THIS CORRECT?** 15 A. No, this is not correct. Any participating customer in this proposed pilot will only be 16 eligible for net metering as governed by Indiana Code 8-1-40 and as stated in our proposed rider. They will not receive any increased economic benefit over other net 17 18 metering customers that do not participate in this proposed program. 19 Q. THE OUCC ALSO ASSERTED THAT THE COMPANY INTENDS TO RETAIN 20 THE FULL VALUE OF ANY INVESTMENT TAX CREDITS ASSOCIATED 21 WITH THE CONSTRUCTION OF FACILITIES UNDER THIS PROGRAM. IS

	No, this is not an accurate statement. As the Company stated in its petition in this					
	proceeding, Duke Energy Indiana, to the extent possible, will take advantage of any tax					
	credits and provide the benefits to participating customers. Duke Energy Indiana is					
	seeking approval to allow the Company to recognize any tax benefits and share them with					
	participating customers. This is why the Company stated "to the extent possible," it will					
	share these benefits with customers – it is Duke Energy Indiana's intent to do so, as long					
	as the proper approvals are in place. The OUCC's testimony is simply inaccurate on this					
	point.					
	V. <u>DUKE ENERGY INDIANA'S REQUEST SHOULD BE NARROWLY</u> <u>CONSTRUED</u>					
Q.	THE OUCC, CAC AND WALMART SUGGEST THAT DUKE ENERGY					
	INDIANA MAY BE THE SOLE ENTITY TO OFFER SOLAR LEASES IN ITS					
	SERVICE TERRITORY AND THAT THIS IS AN ISSUE THE COMMISSION					
	SHOULD ADDRESS IN THIS PROCEEDING. DOES DUKE ENERGY INDIANA					
A.	SHOULD ADDRESS IN THIS PROCEEDING. DOES DUKE ENERGY INDIANA

1		is only whether Duke Energy Indiana may offer this voluntary tariff to up to 10 MW of			
2		its commercial and industrial customers, providing them with another option for			
3		financing, operating and maintaining solar facilities should they be interested in			
4		constructing them on their premises. As stated previously and reiterated in the letters of			
5		support provided by two solar developers, this proposal provides an additional option for			
6		customers in an already competitive market for the construction of onsite solar facilities.			
7		Duke Energy Indiana respectfully suggests that the Commission approve this limited			
8		pilot program and review its performance as it proceeds before determining whether any			
9		broader changes to Indiana law are necessary.			
10		VI. <u>CONCLUSION</u>			
11	Q.	WERE PETITIONER'S EXHIBITS 2-A THROUGH 2-E PREPARED BY YOU			
12		OR UNDER YOUR DIRECTION?			
13	A.	Yes, they were.			
14	Q.	DOES THIS CONCLUDE YOUR TESTIMONY?			
15	A.	Yes, at this time.

#### Standard Contract Rider No. 26 Solar Services Program

#### **Program Description**

The program allows for eligible customers to have solar energy facilities installed on their premises to be constructed, operated, and maintained by the Company. Customers will receive the kwh output and the environmental attributes associated with the solar energy facility.

#### Availability

Available to non-residential customers who are served under one of the following Rate Schedules or Standard Contract Riders:

- Rate CS Schedule for Commercial Electric Service
- Rate LLF Schedule for Low Load Factor Service
- Standard Contract Rider No. 10.1 Optional High Efficiency Total Electric Commercial Service (Applicable to Rate LLF)
- Standard Contract Rider No. 10.2 Optional Time-Of-Use Service (Applicable to Rate LLF)
- Rate HLF, Schedule for High Load Factor Service
- Standard Contract Rider 12.2 Optional Time-Of-Use Service (Applicable to Rate HLF), and
- Rate WP Schedule for Water Pumping and/or Sewage Disposal

Each facility must comply with the requirements of Standard Contract Rider No. 57, Net Metering, and Standard Contract Rider No. 80, Interconnection Service. The Parties will be responsible to adhering to these requirements and meeting all obligations, including but not limited to insurance coverage and indemnification. Each facility must be on a suitable location for the service requested as determined by the Company.

Total participation under this rider is limited to an aggregate amount of solar facility nameplate capacity of 10 MW.

#### Special Terms and Conditions

- Customer and Company shall enter into a Service Agreement defining the obligations of the parties for an initial term no greater than 20 years, with renewal terms thereafter as defined in the Service Agreement. The Service Agreements shall be established under Internal Revenue Code section 7701(e) and in compliance with Indiana Code § 8-1-2.5-6.
- 2. Company will permit Customer to participate in Company's Standard Contract Rider No, 57, Net Metering.
- 3. Company will establish a market based price paid by Customer through negotiation, based on criteria that includes, but is not limited to, an evaluation of the customer's credit worthiness for eligibility under this program. The credit criteria and Customer eligibility shall be at the sole discretion of the Company and may impact project pricing.
- 4. Payment will be made monthly within the time limits established under the terms in the Service Agreement. Customers may be billed separately from their monthly electric bill.
- 5. Termination of the Service Agreement prior to the conclusion of the initial term shall be subject to termination provisions established under the terms in the Service Agreement.
- 6. Customer may assign the terms of this Service Agreement to subsequent owners of the property or building, subject to agreement by the Company.

#### **EXHIBIT B**

#### **General Terms and Conditions**

1. <u>SOLAR ENERGY SERVICES</u>. Customer hereby engages Provider to perform the following services subject to the terms and conditions specified in this Agreement: to install, own, operate and maintain the solar photovoltaic generation system described in <u>Exhibit A</u> attached hereto (the "System") upon Customer's [Premises][Facility] and perform and provide the other services specified in this Agreement, including the provision of renewable electrical energy as described in paragraph 4 (collectively, the "Solar Energy Services") and Provider hereby accepts such engagement subject to the terms and conditions specified in this Agreement. This Agreement is intended to constitute a service agreement under §7701(e) of the Internal Revenue Code and in compliance with [insert applicable Indiana Code/rider or tariff authorizing the lease].

#### 2. TERM; TERMINATION; RESCISSION RIGHT.

- (a) The initial term of this Agreement shall commence on the Commercial Operation Date (as defined below), and shall continue, unless earlier terminated in accordance with its terms, for a period of [twenty (20)] years (the "Initial Term"). Thereafter, this Agreement shall automatically be extended for additional one-year periods, up to a maximum of ten (10) one-year extensions (each one-year extension period being referred to as an "Extension Period"), unless terminated by either Party as provided herein. Either Party may terminate this Agreement at the end of the Initial Term or any Extension Period by giving the other Party written notice at least six (6) months prior to the end of the Initial Term or applicable Extension Period. Customer may terminate this Agreement prior to the expiration of the Term upon payment to Provider of the termination fee specified in Exhibit F attached hereto ("Termination Fee") corresponding to the date of termination. As used herein, "Term" shall mean the Initial Term and any Extension Period(s). As used herein the term "Commercial Operation Date" shall mean the date Provider gives Customer written notice that the System is mechanically complete and capable of providing electric energy to the delivery point identified in Exhibit A.
- (b) Notwithstanding anything herein to the contrary, Customer may rescind this Agreement, without any penalty or obligation, within three (3) business days from the Effective Date as provided in **Exhibit I** hereto.
- 3. <u>MONTHLY PAYMENT</u>. For and in consideration of the Solar Energy Services provided to Customer herein, Customer shall pay to Provider a monthly payment during the Term of the Agreement in the amounts specified in <u>Exhibit C</u>, attached hereto and incorporated herein ("Monthly Payment"). Commencing with the month immediately following the Commercial Operation Date, the Provider shall invoice Customer monthly for the Monthly Payment. The invoice shall be due and payable to Provider on or before [*insert payment date*] of each month at the address specified in the invoice.
- 4. USE OF SYSTEM; ENVIRONMENTAL ATTRIBUTES.

- (a) Use of System. The System shall be installed and operated on the Premises by Provider for the sole intended purpose of providing solar generated electricity to the Customer at the Premises. Customer shall be entitled to one hundred percent (100%) of the output of electricity generated by the System, less that associated with Station Power. In no event shall Customer be permitted to operate the System. As used herein "Station Power" means the electricity generated by the System and, whether metered or unmetered, used on-site to supply the System's auxiliary load and parasitic load and/or for powering the electric generation equipment.
- (b) Environmental Attributes. Provider hereby provides and conveys all Environmental Attributes associated with all electricity generated by the System to Customer as part of the Solar Energy Services being provided hereunder. Provider represents and warrants that Provider holds the rights to all the Environmental Attributes transferred hereunder and Provider agrees to convey good title to all such Environmental Attributes to Customer free and clear of any encumbrances or liens.
- (c) Definition of Environmental Attributes. The term "Environmental Attributes" as used in this Agreement means any and all credits, benefits, emissions reductions, offsets, and allowances, howsoever entitled, attributable to the System, the production of electricity by the System and its displacement of conventional energy generation, including: (a) any avoided emissions of pollutants to the air, soil or water such as sulfur oxides (SOx), nitrogen oxides (NOx), carbon monoxide (CO), and other pollutants; (b) any avoided emissions of carbon dioxide (CO2), methane (CH4), nitrous oxide, hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride, and other greenhouse gases (GHGs) that have been determined by the United Nations Intergovernmental Panel on Climate Change, or otherwise by law, to contribute to the actual or potential threat of altering the Earth's climate by trapping heat in the atmosphere; and (c) the reporting rights related to these avoided emissions, such as Green Tag Reporting Rights and Renewable Energy Credits. Green Tag Reporting Rights are the right of a party to report the ownership of accumulated Green Tags in compliance with federal or state law, if applicable, and to a federal or state agency or any other party, and include Green Tag Reporting Rights accruing under Section 1605(b) of The Energy Policy Act of 1992 and any present or future federal, state, or local law, regulation or bill, and international or foreign emissions trading program. Environmental Attributes do not include depreciation benefits and tax credits. Without limiting the generality of the foregoing, Environmental Attributes include carbon trading credits, renewable energy credits or certificates, emissions reduction credits, emissions allowances, green tags tradable renewable credits, and Green-e® products.

#### 5. INSTALLATION; OPERATION AND MAINTENANCE; USE OF CONTRACTORS.

(a) <u>Installation of System</u>. Subject to the conditions set forth in Section 6 below, Provider shall construct, own, and install the System at a location on the [Premises][Facility], to be mutually agreed upon by Provider and Customer, in accordance with a System design to be reviewed by Customer prior to installation. Provider shall use commercially reasonable efforts to obtain (i) any zoning, land use, electrical and building permit required to construct, install and operate the System; and (ii) any agreements and approvals from [INSERT name of the

interconnecting utility], LLC (the "Utility") necessary in order to interconnect the System to the electrical system at the Premises and/or the Utility's electric distribution system.

- (b) Operation and Routine Maintenance of the System. Subject to Section 28, Provider shall be responsible for operation, and routine maintenance and repair of the System, at Provider's sole cost and expense; provided however, Customer shall reimburse Provider for the cost of any repairs to the System resulting from Customer's negligence, willful misconduct or breach of this Agreement. Provider shall operate, maintain and repair the System in accordance with all applicable laws, including applicable requirements of the National Electric Safety Code, the National Electrical Code, and the Utility's interconnection standards if applicable.
- (c) <u>Use of Contractors and Subcontractors</u>. It is understood and agreed that Provider shall be permitted to use contractors to perform its obligations under this Agreement. Notwithstanding the use of contractors engaged by Provider, Provider shall remain fully liable for the performance of its obligations and such delegation shall not relieve Provider from any of Provider's obligations or liabilities under this Agreement. Provider shall cause the contractor to comply with the terms and conditions of this Agreement in the performance of any work performed hereunder.
- 6. <u>CONDITIONS TO PROVIDER'S OBLIGATIONS</u>. Provider's obligations under this Agreement are conditioned on the completion of the following conditions to Provider's satisfaction within after the Effective Date (the "**Provider's Review Period**"):
  - (a) Completion of a physical inspection of the Premises by Provider including, if applicable, geotechnical work and real estate due diligence to confirm the suitability of the Premises for the System;
  - (b) Approval by Provider and its lender if applicable, of (A) the construction agreement (if any) for the engineering, procurement, construction and installation of the System, and (B) the credit quality of Customer, or its credit support provider as applicable;
  - (c) With the assistance of Customer as contemplated in this Agreement, receipt of all necessary zoning, land use, electrical, and building permits;
  - (d) Execution of all necessary agreements with the Utility for interconnection of the System to the Facility electrical system and/or the Utility's electric distribution system;
  - (e) [(If required on a case by case basis) Execution by Provider and the Premises owner of a site lease in the form of Schedule 6(e) (the "Site Lease") wherein Premises owner shall grant Provider an exclusive lease for a period of time expiring as established in the Site Lease to access, construct, install, operate, maintain, repair, replace and remove the System on the Premises and to perform Provider's obligations under this Agreement.]
  - (f) Provider's receipt of (i) written confirmation to its satisfaction from any person holding a mortgage, lien, or other encumbrance over the Premises, that such person will

recognize Provider's rights under this Agreement for as long as Provider is not in default hereunder; (ii) if Customer does not own the Premises, upon request of Provider, Customer shall obtain and deliver to Provider all consents from the owner of the Premises to grant the License (as defined below) and any required Easements, as determined by Provider in its discretion. As used herein the term "Easement" shall mean an easement suitable for recording in the state in which the Premises is located in a form acceptable to Provider; and

- (g) Provider's receipt of a signed and notarized original of the Memorandum of License (as defined herein) or fully executed and notarized original of the Easement (if applicable).
- (h) <u>Failure of Conditions</u>. If any of the conditions listed in subsections (a) through (g) of Section 6 are not satisfied by the end of Provider's Review Period, the Parties will attempt in good faith to negotiate new dates for the satisfaction of the failed conditions. If the Parties are unable to negotiate new dates then Provider may terminate this Agreement upon 10 days written notice to Customer, and neither Party shall have liability for costs or damages or triggering a default under this Agreement incurred by the other Party.
- 7. <u>METERING</u>. Provider shall design, construct, install, operate, calibrate and maintain the metering devices needed to measure the electric energy generated by the System by means of solar generation at Provider's cost and expense. Metering shall be compatible with MV-90 interrogation software or Itron Enterprise Edition software and both Parties shall have unlimited rights to interrogate the meter for the System. The metering devices shall provide Customer and the Utility the ability to continuously monitor generation and unit status from the System. Provider shall test the metering devices annually at its expense. Provider shall notify Customer prior to performing such tests and Customer shall be allowed to have a representative present to witness such tests. Metering equipment that fails to register, or is found upon testing to be inaccurate by more than 1%, shall be repaired, adjusted or replaced by Provider, at its expense.

#### 8. LICENSE TO PREMISES; SYSTEM ACCESS BY PROVIDER.

Customer hereby grants to Provider and to Provider's agents, employees, (a) contractors and assigns an irrevocable non-exclusive license running with the Premises (the "License") for access to, on, over, under, and across the Premises for the purposes of (i) installing, constructing, operating, owning, accessing, removing and replacing the System on the area(s) depicted on **Exhibit D** attached to this Agreement which area(s) shall be referred to herein (collectively, as applicable) as the "License Area"; (ii) performing all of Provider's obligations and enforcing all of Provider's rights set forth in this Agreement; and (iii) installing and using electric lines and equipment, including inverters and meters necessary to interconnect the System to Customer's electric system at the Premises, to the Utility's electric distribution system, if any, or for any other purpose that may from time to time be useful or necessary in connection with the construction, installation or operation of the System. Provider shall notify Customer prior to entering the Premises except in situations where there is imminent risk of damage to persons or property. The term of the License shall continue until the date that is 180 days following the date of expiration (as may be extended or renewed) or termination of this Agreement (the "License Term"). During the License Term, Customer shall ensure that Provider's rights under the License and Provider's access to the Premises and the System are preserved and protected.

Customer shall not interfere with nor shall Customer permit any third parties to interfere with such rights or access. At request of Provider, Customer shall execute a memorandum of license in a form reasonably acceptable to Provider (the "Memorandum of License").

- (b) In the event Provider must access the Premises, excepting emergencies, it agrees to use commercially reasonable efforts to schedule access during a mutually agreeable time. Customer agrees to comply with any safety and security requirements that may be applicable to the Premises.
- 9. <u>CUSTOMER'S OBLIGATION TO MAINTAIN THE PREMISES</u>. Customer shall maintain the [Premises][and the Facility] in good condition, reasonable wear and tear excepted. Customer shall not take or permit any action on or about the [Premises] [or the Facility] that would cause the System not to operate as intended. Customer shall notify Provider if the System is not operating as intended.
- 10. <u>INSOLATION</u>. Customer understands that unobstructed access to sunlight ("**Insolation**") is essential to Provider's performance of its obligations and a material term of this Agreement. Customer shall not in any way cause and, where possible, shall not in any way permit any interference with the System's Insolation. If Customer becomes aware of any activity or condition that could diminish the Insolation of the System, Customer shall notify Provider immediately and shall cooperate with Provider in preserving the System's existing Insolation levels. The Parties agree that reducing Insolation would irreparably injure Provider, that such injury may not be adequately compensated by an award of money damages, and that Provider is entitled to seek specific enforcement of this Section 10 against Customer.
- 11. <u>DATA LINE</u>. If requested by Provider, Customer shall provide Provider access to the Customer's existing (at the time of the request) high-speed internet data line during the Term to enable Provider to record the Energy; provided, that if Customer does not have any high-speed internet data line at the time of Provider's request, Customer and Provider shall cooperate, at Provider's reasonable cost and expense, to install and provide a high-speed internet data line.
- 12. NO WARRANTY. OTHER THAN THE PRODUCTION GUARANTY SPECIFIED IN EXHIBIT H ATTACHED HERETO, NO WARRANTY OR REMEDY, WHETHER STATUTORY, WRITTEN, ORAL, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, OR WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE, SHALL APPLY TO THIS AGREEMENT OR ANY SERVICES PERFORMED HEREUNDER. The remedies set forth in this Agreement shall be Customer's sole and exclusive remedies for any claim or liability arising out of or in connection with this Agreement, including any Services performed hereunder, whether arising in contract, tort (including negligence), strict liability, or otherwise.
- 13. <u>GOVERNMENTAL APPROVALS</u>. It is understood and agreed that Provider's obligations under this Agreement are contingent upon its obtaining, after the execution date of this Agreement, all of the certificates, permits and other approvals that may be required by any Federal, State or Local authorities (collectively the "Governmental Approvals") in order to permit construction, operation and use of the System as set forth herein. Customer shall cooperate with

Provider in its effort to obtain such Governmental Approvals and shall take no action which would adversely affect the status of the Premises with respect to the proposed use of the System. In the event that any of such applications for such Governmental Approvals should be finally rejected or Provider determines that such Governmental Approvals may not be obtained in a timely and commercially reasonable manner or any Governmental Approval issued to Provider is canceled, expires, lapses, or is otherwise withdrawn or terminated by governmental authority or that Provider determines that the site is no longer technically compatible for its use or that Customer, in its sole discretion, will be unable to use the System for its intended purposes, Provider shall have the right to terminate this Agreement without liability. Notice of Provider's exercise of its right to terminate shall be given to Lessee in writing.

- 14. <u>INDEMNIFICATION</u>. Each Party shall indemnify and hold the other harmless against any third party claim of liability or loss from bodily injury/death or property damage resulting from or arising out of the use and occupancy of the System or Premises by the Party, its servants or agents, excepting, however, such claims or damages as may be due to or caused by the acts or omissions of the other Party, or its servants or agents. Provider shall indemnify and hold harmless Customer from and against any third party claim of liability or loss from bodily injury/death or property damage resulting from or arising out of Provider's installation, operation, maintenance, repair or removal of the System, except to the extent liability is due to the negligence, gross negligence or willful misconduct of Customer.
- FORCE MAJEURE. The term "Force Majeure," as used in this Agreement, means causes 15. or events (i) beyond the reasonable control of the Party claiming Force Majeure, (ii) that could not be reasonably avoided, prevented, or removed by a Party's use of commercially reasonable efforts, and (iii) without the fault or negligence of the Party claiming Force Majeure. So long as the requirements of the preceding sentence are met, Force Majeure shall include, without limitation, the failure or interruption of the production, delivery or acceptance of electricity or performance of the Solar Energy Services due to: (i) acts of God, sudden actions of the elements, including floods, earthquakes, volcanic activity, hurricanes, lightning, hail, ice storms, tornadoes or excessive winds; (ii) sabotage; vandalism beyond that which could reasonably be prevented by the claiming Party; (iii) terrorism, war, riots, fire, explosion, blockades, insurrection, strike, slow down or labor disruptions (even if such difficulties could be resolved by conceding to the demands of a labor group); (iv) actions or inactions by any U.S. governmental authority with jurisdiction over the claiming Party taken after the date hereof but only if such actions, or inactions prevent or delay performance of a Party hereunder (and provided that such actions or inactions are not the result of such Party's failure to comply with applicable law); (v) unavailability of electricity from the grid; and (vi) inability, despite due diligence, to obtain any equipment (including solar panels), supplies or products, licenses, permits, or approvals required by any U.S. governmental authority with jurisdiction over the claiming Party and the issuance of any order, injunction, or other legal or equitable decree interfering with the performance of a Party's obligations hereunder.
  - (a) Neither Party shall be responsible or liable for any delay or failure in its performance under this Agreement, nor shall any delay, failure, or other occurrence or event become an Event of Default, to the extent such delay, failure, occurrence or event is substantially caused by conditions or events of Force Majeure, provided that:

- (i) the non-performing Party gives the other Party prompt written notice describing the particulars of the occurrence of the Force Majeure;
- (ii) the suspension of performance is of no greater scope and of no longer duration than is required by the Force Majeure;
- (iii) the non-performing Party proceeds with reasonable diligence to remedy its inability to perform and provides weekly progress reports to the other Party describing actions taken to end the Force Majeure; and
- (iv) when the non-performing Party is able to resume performance of its obligations under this Agreement, that Party shall give the other Party written notice to that effect.
  - (b) Except as otherwise expressly provided for in this Agreement, the existence of a condition or event of Force Majeure shall not relieve the Parties of their obligations under this Agreement (including, but not limited to, payment obligations) to the extent that performance of such obligations is not precluded by the condition or event of Force Majeure.
  - (c) <u>Termination Due to Force Majeure</u>. In the event that any delay or failure of performance caused by conditions or events of Force Majeure continues for an uninterrupted period of three hundred sixty (360) days from its occurrence or inception, as noticed pursuant to this Section 15, the Party not claiming Force Majeure may, at any time following the end of such three hundred sixty (360) day period, terminate this Agreement upon written notice to the non-claiming Party, without further obligation by either Party other than costs and balances incurred prior to the effective date of such termination which remain unpaid. The Party not claiming Force Majeure may, but shall not be obligated to, extend such three hundred sixty (360) day period, for such additional time as it, at its sole discretion, deems appropriate, if the affected Party is exercising due diligence in its efforts to cure the conditions or events of Force Majeure. Upon termination of this Agreement as a result of Force majeure in accordance with this section 15(c), Provider shall remove the System from the Premises within one hundred twenty (120) days of termination, at Provider's expense.
- 16. <u>INSURANCE</u>. At all times during the Term, Provider and Customer shall maintain the following insurance and comply with the following requirements:
  - (a) <u>Provider's Insurance</u>. Provider and/or its contractors shall maintain (A) commercial general liability insurance with coverage of at least \$1,000,000 per occurrence and \$2,000,000 annual aggregate, (B) employer's liability insurance with coverage of at least \$1,000,000, (C) property coverage on the System, and (D) workers' compensation insurance as required by law. Provider reserves the right to self-insure for all insurance coverages and obligations under this Agreement.
  - (b) <u>Customer's Insurance</u>. Customer shall maintain (A) property coverage on the Premises [and the Facility], (B) commercial general liability insurance with coverage of at least \$1,000,000 available per occurrence and \$2,000,000 annual aggregate for contractual liability, personal injury, bodily injury to or death of persons, and/or loss of use or damage to property and explosion, collapse, and underground hazard coverage, and (C) worker's compensation insurance as required by law.

- (c) <u>Certificates</u>. Upon the other Party's request each Party shall deliver the other Party certificates of insurance evidencing the above required coverage. A Party's receipt, review or acceptance of such certificate shall in no way limit or relieve the other Party of the duties and responsibilities to maintain insurance as set forth in this Agreement.
- (d) <u>Deductibles</u>. Each Party shall be responsible for the payment of its own deductibles and/or retentions.
- (e) <u>Waiver of Subrogation</u>. Provider and Customer each release each other and their respective principals, employees, agents, and representatives, from any claims for damage or injury to any person, the System, or to the Premises, Customer's other assets that are on the Premises or to the System caused by, or that result from, risks insured against under any property or casualty insurance policies carried by the Parties (or required to be maintained under the terms of this Agreement or any self-insurance program) and in force at the time of any such damage or claim (or which should have been in force under the terms of this Agreement). Provider and Customer shall, and shall cause each such insurance policy obtained by them, to provide that the insurance company waives all right of recovery by way of subrogation against the other in connection with any claims or damage covered by any such policy, as permitted by law. Neither Provider nor Customer shall be liable to the other for any damage caused by fire, collapse or any of the risks insured against under any insurance coverage required by this Section 16.
- (f) <u>Additional Insured</u>. Customer shall include Provider and its directors, officers, managers, members, employees, affiliates and subcontractors as additional insureds on all commercial general liability insurance policies with respect to Customer's acts, omissions, or operations, whether in whole or in part.

All insurance policies provided and maintained by Customer shall: (i) be underwritten by insurers which are rated A.M. Best "A- VII" or higher; (ii) provide that such policies and additional insured provisions are primary with respect to the acts, omissions, services, or operations of the Customer, whether in whole or in part, and without right of contribution from any other insurance, or coverage available to Provider and its affiliates; and (iii) contain standard cross liability clause, separation of insured and severability of interest provisions except with respect to the limits of the insurer's liability. All insurance policies shall provide that the insurer will provide at least thirty (30) days' written notice to the Customer, who in turn shall provide at least thirty (30) days' written notice to Provider prior to cancellation or non-renewal of any policy (or ten (10) days' notice in the case of non-payment of premium).

17. <u>REMOVAL OF SYSTEM UPON EXPIRATION OR TERMINATION</u>. Upon the expiration or earlier termination of this Agreement, Provider, shall, within [one hundred twenty (120)] days, remove the System from the [Premises] [Facility].

Customer agrees and acknowledges that the System shall be deemed conclusively for the purposes of this Agreement to be personal property (and not fixtures) and shall remain the personal property of Provider and Provider shall have the right to remove the same or to direct the removal of the System, whether or not said items are considered fixtures and attachments to real property under applicable law.

- 18. <u>TITLE TO PREMISES</u>. Customer covenants that Customer is (and will be throughout the Term) seized of good and sufficient title or leasehold interest in the Premises and has full authority to enter into and execute this Agreement and to perform its obligations hereunder. Customer further covenants that there are no liens, judgments or impediments of title affecting the Premises or affecting Customer's title or leasehold interest to the same except as set forth on <u>Exhibit E</u> attached hereto, and that there are no covenants, easements or restrictions which prevent the use of the System or the Premises [Facility] by the Customer as contemplated in this Agreement. To the extent that there is(are) existing mortgage(s) or any other interests superior to this Agreement affecting the Premises, or Customer's leasehold interest in the Premises, Provider and Customer shall cooperate and make best efforts in promptly causing each such mortgagee and/or other interest holder (as applicable) to execute and deliver an agreement subordinating or releasing such superior interests to Provider's rights under this Agreement in a form reasonably satisfactory to Provider and Customer's mortgagee and/or other interest holder.
- 19. TAXES AND INCENTIVES. Provider shall pay all taxes due and payable for the System. Customer shall pay all ad valorem taxes due and payable on the Premises and any other taxes on Customer's personal property. In addition, Provider shall be treated for income tax purposes as the owner of the System and in computing its income tax liabilities shall be: (i) entitled to claim all items of deduction (including accelerated depreciation under Section 168 of the Code), loss, credit (including the energy credit under Section 48 of the Internal Revenue Code of 1986, as amended (the "Code")), and similar income tax benefits relating to ownership of the System as owners of similar properties are entitled to under the Code and applicable state tax laws in effect on the date hereof; and (ii) responsible for reporting all items of income, gain, and similar income tax burdens as owners of similar properties are responsible for under the Code and applicable state tax laws in effect on the date hereof.
- 20. VACATION OR TRANSFER OF THE PREMISES. If Customer ceases to conduct business operations at or vacates the Premises, or sells or assigns its interest in the Premises or a leasehold in the Premises, as applicable, prior to the expiration of the Initial Term or Extension Period, as applicable, Customer shall have the following options: (i) with the consent of Provider (which shall not be unreasonably withheld), Customer may assign the Agreement to the new owner of the Premises or holder of the leasehold interest, provided the new owner of the Premises or holder of the leasehold interest signs an agreement (in the form approved by Provider) assuming all of Customer's rights and obligations under this Agreement; or (ii) terminate the Agreement upon payment of the Termination Fee corresponding to the date of termination as provided in Section 2 and Exhibit F. Customer shall provide Provider not less than 90 days prior written notice of the intended cessation of business operations or vacation of the Premises, or sale or assignment of its interest in the Premises or a leasehold in the Premises, as applicable, which notice shall identify the name of the new owner if Customer proposes to transfer the Agreement. Customer understands that any new owner of the Premises or leasehold to whom Customer desires to transfer the Agreement must, among other things, satisfy Provider's credit requirements.
- 21. <u>LIENS</u>. Customer shall not directly or indirectly cause, create, incur, assume, or allow to exist any mortgage, pledge, lien, charge, security interest, encumbrance, or other claim of any nature on or with respect to the System or any interest therein. Customer shall immediately notify Provider in writing of the existence of any such mortgage, pledge, lien, charge, security interest, encumbrance, or other claim, shall promptly cause the same to be discharged and released of record

without cost to Provider, and shall indemnify Provider against all costs and expenses (including reasonable attorneys' fees) incurred in discharging and releasing any such mortgage, pledge, lien, charge, security interest, encumbrance, or other claim. Notwithstanding anything else herein to the contrary, Provider may grant a lien on the System (in accordance with Section 22) and may assign, mortgage, pledge, or otherwise collaterally assign its interests in this Agreement (in accordance with Section 32), and the System to any lender or financier.

22. <u>OWNERSHIP OF SYSTEM; WAIVER OF CUSTOMER'S LIEN</u>. It is the intention of the Parties that the System shall at all times be owned by and remain Provider's personal property and/or trade fixtures and shall not be "real fixtures." Customer waives any lien rights it may have concerning the System and Provider has the right to remove all or any portion(s) of the System at any time.

#### 23. CREDIT AND RELATED PROVISIONS.

- (a) <u>Performance Assurance Requirements</u>. Subject to Section 23(b) below, no later than five (5) business days after the Effective Date, Customer shall provide and deliver to Provider Performance Assurance in the amount of [\$\_\_\_\_\_] as set forth in the below table corresponding to the applicable period during the Term of this Agreement [Insert Annual Performance Assurance Table]
- (b) <u>Unsecured Credit For Creditworthy Customers</u>. If Customer is Creditworthy and throughout the Term is not in default of any provisions under this Agreement, the Customer shall be excused from the requirement to post Performance Assurance as required under Section 23(a) above, as long as it remains Creditworthy. If at any time during the Term of this Agreement, Customer, or its Guarantor, ceases to be Creditworthy due to a change in its Credit Rating or Provider's reasonable determination that the Customer or Guarantor is no longer Creditworthy, then Customer will notify Provider of such change in its credit status and Customer shall provide Performance Assurance to Provider in the amounts required under Section 23(a), within five (5) Business Days after such change in its Credit Rating or notice from Provider that the Customer or Guarantor is no longer Creditworthy.

#### (c) <u>Definitions used in this Section.</u>

- (i) "Credit Rating" means, with respect to any entity, the rating then assigned to such entity's unsecured, senior long-term debt obligations (not supported by third party credit enhancements) or if such entity does not have a rating for its senior unsecured long-term debt, then the rating then assigned to such entity as a corporate or issuer rating.
- (ii) "Creditworthy" or "Creditworthiness" means (i) a person or entity with an investment grade Credit Rating from at least one (1) of the Rating Agencies such that its senior unsecured debt (or issuer rating if such person or entity has no senior unsecured debt rating) is rated at least BBB- by S&P, if rated by S&P, or Baa3 by Moody's, if rated by Moody's, or (ii) has satisfactory and verifiable creditworthiness determined in Provider's sole discretion. Notwithstanding the foregoing, a person or entity that does not have an investment grade Credit Rating may submit complete audited financial statements (or substantially equivalent information certified by an appropriate officer of such entity) for review by the Provider, which shall make

determinations throughout the Term of the entity's creditworthiness on a commercially reasonable basis for purposes of this Agreement. Unaudited or incomplete financial information will negatively impact the determination of creditworthiness.

- (iii) "Guarantor" means any Creditworthy person or entity having the authority and agreeing to guarantee the Customer's obligations under this Agreement and which is otherwise acceptable to Provider in its sole discretion.
- (iv) "Guaranty" means a parent company guaranty, in substantially the form set forth in Exhibit N attached hereto, provided by a Guarantor in favor of Provider guaranteeing the obligations of Customer under this Agreement.
- (v) "Letter(s) of Credit" means one or more irrevocable standby letters of credit in the form of Exhibit O attached hereto, issued by a U.S. commercial bank or other financial institution reasonably acceptable to Provider, which is not an Affiliate of Customer, which has and maintains a Credit Rating of at least A- from S&P and A3 from Moody's, permitting Provider to draw the entire amount if either such amount is owed or such Letter of Credit is not renewed or replaced at least thirty (30) business days prior to its stated expiration date, and is otherwise acceptable in all respects to Provider in its sole discretion.
- (vi) "Moody's" means Moody's Investors Service, Inc. or any successor-rating agency thereto.
- (vii) "Rating Agency" or "Rating Agencies" means the rating entities of S&P or Moody's.
- (viii) "Performance Assurance" means collateral in the form of either cash, Letter(s) of Credit or a Guaranty that is acceptable to Provider in its sole discretion, in each case that meets the requirements set forth in this Agreement provided by Customer to Provider for the benefit of Provider pursuant to this Agreement, as credit support, adequate assurances, and security to secure Customer's performance under this Agreement.
- (ix) "S&P" means Standard & Poor's Ratings Services, Inc. or any successor-rating agency thereto.
- 24. <u>FINANCIAL DISCLOSURES</u>. Customer shall timely provide to Provider financial information of Customer as follows: (i) within 120 days after the end of each fiscal year that this Agreement is effective a copy of Customer's annual report containing audited consolidated financial statements for such fiscal year; and, (ii) upon request of Provider, a copy of Customer's most recent quarterly report containing unaudited consolidated financial statements for such fiscal quarter signed and verified by an authorized officer of Customer attesting to their accuracy. The statements shall be prepared in accordance with generally accepted accounting principles or other procedures with which Seller is required to comply with under applicable law. If such information is available on a publicly available web site, then this requirement shall be deemed to be satisfied. If Customer does not have audited financial statements, Customer shall deliver to Provider financial statements in a form acceptable to Provider and certified by a financial officer of Customer.

25. <u>PURCHASE OF SYSTEM</u>. Upon expiration of the then applicable Term (the "**Option**" Purchase Date"), and provided Customer is not in default under this Agreement, Customer shall have the option of purchasing the System from Provider for its Good Standing Purchase Price in accordance with Exhibit G attached hereto. Customer must provide notice in writing to Provider of its intent to purchase at least 90 days and not more than 180 days prior to the Option Purchase Date, and the purchase shall be completed prior to or effective as of the Option Purchase Date. Any such purchase shall be on an "as-is, where-is basis" free and clear of any liens attributable to payments owed to any third parties by Provider. Customer shall pay any and all sales and use and other transfer taxes due on such transfer. Provider shall not be required to make, and may specifically disclaim, any representation or warranty as to the condition of such System and other matters (except that Provider shall warrant that the System is free and clear of any liens attributable to Provider). At Customer's expense, Provider shall promptly execute and deliver to Customer such statements of termination as reasonably may be required in order to release or terminate any interest of Provider in and to the System and the collateral, and perform such other actions as Customer may reasonably request to effectuate the foregoing. Upon purchase of the System, Customer shall take title to the System and assume complete responsibility for the System, and Provider shall have no further liabilities or obligations hereunder. Notwithstanding anything herein to the contrary, the Customer's option to purchase set forth in this Section 25 and Exhibit G shall not be applicable in the case of an early termination of this Agreement.

#### 26. DEFAULT, REMEDIES AND DAMAGES.

- (a) <u>Default</u>. Either Party that fails to perform under this Agreement in the manner listed below or experiences any of the circumstances listed below shall be deemed to be the "**Defaulting Party**," the other Party shall be deemed to be the "**Non-Defaulting Party**," and each event of default shall be a "**Default Event**":
- (i) Failure by Customer to make the Monthly Payment when due and such failure continues for a period of three (3) days thereafter ("**Payment Default**");
- (ii) Failure by a Party to substantially perform any of its obligations under this Agreement (other than payment of the Monthly Payment by Customer) within thirty (30) days after receipt of written notice from the Non-Defaulting Party demanding such cure; provided, the Defaulting Party shall have such extended period as may be required beyond the thirty (30) days if the nature of the cure is such that it reasonably requires more than thirty (30) days to cure and the Defaulting Party commences the cure within the thirty (30) day period and thereafter continuously and diligently pursues the cure to completion;
- (iii) If any representation or covenant of a Party proves at any time to have been incorrect in any material respect when made and is material to the transactions contemplated hereby, if the effect of such incorrectness is not cured within thirty (30) days following receipt of written notice from the Non-Defaulting Party demanding such cure; or
- (iv) Customer becomes insolvent or is a party to a bankruptcy, reorganization, insolvency, liquidation, receivership, dissolution, winding-up or relief of debtors, or any general assignment for the benefit of creditors or other similar arrangement or any event occurs or proceedings are taken in any jurisdiction with respect to Customer which has a similar effect, and,

if any such bankruptcy or other proceedings were initiated by a third party, if such proceedings have not been dismissed within sixty (60) days following receipt of a written notice from the Non-Defaulting Party demanding such cure.

#### (b) <u>Remedies</u>.

- (i) Remedies for Payment Default. If a Payment Default occurs, Provider may suspend performance of its obligations under this Agreement, which suspension right shall include, without limitation, the right for Provider to disconnect the System until receipt by Provider of the applicable overdue Monthly Payment. Further, Provider may (A) at any time during the continuation of the Default Event, terminate this Agreement upon five days prior written notice to Customer, and (B) pursue any remedy under this Agreement, at law or in equity, including an action for damages.
- (ii) Remedies for Other Defaults. On the occurrence of a Default Event other than a Payment Default, the Non-Defaulting Party may (A) at any time during the continuation of the Default Event, terminate this Agreement or suspend its performance of its obligations under this Agreement, upon five days prior written notice to the Defaulting Party, and (B) pursue any remedy under this Agreement, at law or in equity, including an action for damages. Nothing herein shall limit either Party's right to collect damages upon the occurrence of a breach or a default by the other Party that does not become a Default Event.
  - (c) <u>Damages Upon Termination for Default</u>. Upon a termination of this Agreement by the Non-Defaulting Party as a result of a Default Event by the Defaulting Party, the following shall apply:
- (i) <u>Customer Default</u>. If Customer is the Defaulting Party and Provider terminates this Agreement prior to the expiration of the Term, Customer shall pay to Provider, as liquidated damages and not as a penalty, the Termination Fee in <u>Exhibit F</u> corresponding to the date of termination, plus all other amounts due and owing by Customer under this Agreement at the date of termination. The Parties agree that actual damages to Provider for the loss of Monthly Payments in the event this Agreement terminates prior to the expiration of the Term as the result of a Default Event by Customer would be difficult to ascertain, and the termination payment set forth herein is a reasonable approximation of the damages suffered by Provider for loss of Monthly Payments as a result of such termination. Upon such termination, the System will remain the personal property of Provider and be subject to removal as provided in Section 17.
- (ii) <u>Provider Default</u>. If Provider is the Defaulting Party and Customer terminates this Agreement, Provider shall, at its sole cost and expense, remove the System from the Premises.
- (iii) <u>Mitigation</u>. The Non-Defaulting Party shall take all commercially reasonable efforts to mitigate its damages as the result of a Defaulting Event.
- (iv) EXCEPT WITH RESPECT TO INDEMNIFICATION FOR THIRD PARTY CLAIMS PURSUANT TO SECTION 14 HEREUNDER, NEITHER PARTY SHALL BE LIABLE TO THE OTHER PARTY FOR ANY SPECIAL, PUNITIVE, EXEMPLARY, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES, OR LOSSES OR DAMAGES

FOR LOST REVENUE, LOST INCOME, LOST PROFITS, LOST BUSINESS OR ANY BUSINESS INTERRUPTION WHETHER FORESEEABLE OR NOT, ARISING OUT OF, OR IN CONNECTION WITH THIS AGREEMENT OR THE TRANSACTIONS OR RELATIONSHIP BETWEEN THE PARTIES CONTEMPLATED UNDER THIS AGREEMENT, EVEN IF THE PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF THE DAMAGES AND REGARDLESS OF ANY PRIOR COURSE OF DEALING BETWEEN THE PARTIES.

27. <u>LIMITATION OF LIABILITY</u>. NOTWITHSTANDING ANYTHING TO THE CONTRARY CONTAINED HEREIN, THE TOTAL CUMULATIVE LIABILITY OF PROVIDER FOR ANY AND ALL CLAIMS OR DAMAGES ARISING UNDER OR IN CONNECTION WITH THIS AGREEMENT (WHETHER STATED IN CONTRACT, TORT, STRICT LIABILITY OR ANY OTHER THEORY OF LAW OR EQUITY) AT ANY TIME SHALL NOT EXCEED \$\_\_\_\_\_\_ IN THE AGGREGATE; PROVIDED, THAT THIS LIMITATION SHALL NOT APPLY TO ANY DAMAGES SUSTAINED BY CUSTOMER AS A RESULT OF (I) THE FRAUD, GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF PROVIDER OR ITS EMPLOYEES OR AUTHORIZED AGENTS OR (II) ANY INDEMNIFICATION CLAIM UNDER SECTION 14 RESULTING FROM THIRD PARTY DEATH OR BODILY INJURY.

## 28. <u>CASUALTY; CONDEMNATION</u>.

- (a) <u>CASUALTY</u>. In the event that the System or any portions thereof are damaged or destroyed by fire or other casualty during the Term, and if in Provider's sole judgment the damage is of such nature or extent that it is uneconomical to repair or restore the System, then Provider may terminate this Agreement by written notice to Customer. Any such notice of termination shall cause this Agreement to expire with the same force and effect as though the date set forth in such notice were the date originally set as the expiration date of this Agreement. Notwithstanding the foregoing, Customer shall be responsible for and shall be liable to Provider for any damage or destruction of the System to the extent caused by the negligence or willful misconduct of Customer, its employees, agents or contractors.
- (b) <u>CONDEMNATION</u>. Customer shall give Provider immediate notice of any condemnation action threatened or instituted affecting the Premises. In the event of any condemnation of all or any portion(s) of the Premises which may reasonably be expected to disrupt operation of the System at the Premises for more than forty-five (45) days, Provider or Customer may terminate this Agreement upon fifteen (15) days written notice to the other Party. Provider may on its own behalf make a claim in any condemnation proceeding involving the Premises for losses related to the System and its damages and losses (but not for the loss of its leasehold interest). Any such notice of termination shall cause this Agreement to expire with the same force and effect as though the date set forth in such notice were the date originally set as the expiration date of this Agreement.
- 29. <u>NOTICES</u>. All notices hereunder must be in writing and shall be deemed validly given if sent by certified mail, return receipt requested or by commercial courier, provided the courier's regular business is delivery service and provided further that it guarantees delivery to the addressee by the end of the next business day following the courier's receipt from the sender, addressed to

the Party at the address specified in Exhibit A (or any other address that the Party to be notified may have designated to the sender by like notice).

Notice shall be effective upon mailing or delivering the same to a commercial courier, as permitted above.

- 30. <u>INTEGRATION</u>. It is agreed and understood that this Agreement (including its Exhibits) contains all agreements, promises and understandings between the Provider and Customer and that no verbal or oral agreements, promises or understandings shall be binding upon either the Provider or Customer in any dispute, controversy or proceeding at law, and any addition, variation or modification to this Agreement shall be void and ineffective unless made in writing signed by the Parties. In the event any provision of this Agreement is found to be invalid or unenforceable, such finding shall not affect the validity and enforceability of the remaining provisions of this Agreement. The failure of either Party to insist upon strict performance of any of the terms or conditions of this Agreement or to exercise any of its rights under this Agreement shall not waive such rights and such Party shall have the right to enforce such rights at any time and take such action as may be lawful and authorized under this Agreement, either in law or in equity.
- 31. <u>GOVERNING LAW</u>. This Agreement and the performance thereof shall be governed, interpreted, construed and regulated by the laws of the State of Indiana, without reference to its conflicts of laws provisions.

#### 32. ASSIGNMENT.

- (a) Restriction of Assignments and Change of Control by Customer.
- (i) <u>Assignment</u>. Customer shall not assign this Agreement, any rights or obligations under the Agreement, or any portion hereunder, without Provider's prior written consent, which shall not be unreasonably withheld. Customer shall give Provider at least thirty (30) days prior written notice of any requested assignment. Any permitted assignee shall agree in writing to be bound by the terms and conditions of this Agreement, including any credit requirements, and shall deliver to Customer any required Performance Assurance and enforceability assurance as Provider may reasonably request.
- (ii) <u>Change of Control</u>. Any Change of Control of Customer (however this Change of Control occurs) shall require the prior written consent of Provider, which shall not be unreasonably withheld. Customer shall give Provider at least thirty (30) days prior written notice of any such requested consent to a Change of Control.
- (iii) <u>No Release</u>. Notwithstanding the foregoing, any assignment or Change of Control will not release Customer of its obligations hereunder, unless Provider agrees in writing to such a release. Any assignment in violation of this provision shall be void.
  - (b) <u>Provider's Assignment Without Consent</u>. This Agreement may be sold, assigned, pledged or transferred by Provider, without any approval or consent of the Customer as follows: (i) to a purchaser of the System or of all or substantially all of the assets of Provider; (ii) to an Affiliate of Provider; (iii) in connection with a merger of Provider with another Person or any

other transaction resulting in a Change of Control of Provider (iv) in connection with a contribution or any other transaction undertaken to facilitate an investment in Provider by a Tax Equity Investor as provided is subparagraph (c) below; or (v) in connection with the pledge or grant of a security interest in the System and/or this Agreement by Provider to any lender (including any Project Lender) or investor; provided however, in the case of items (i), (ii), (iii) and Upon any permitted assignment of this Agreement by Provider (other than pursuant to Section 32(b)(iv)) and such assignee's written assumption of this Agreement, the Provider shall be released from the performance of its obligations under this Agreement for the period from and after the date of such assignment and assumption. Additionally, Provider may, upon notice to Customer, grant a security interest in the System, and may collaterally assign the System to any lender or investor (including any Project Lender), including its successors or assigns, upon the condition that all rights acquired under such security interest or collateral assignment shall, except as expressly provided otherwise herein, be subject on a going forward basis after such rights are acquired to the covenants, conditions and restrictions set forth in this Agreement. In the event that Provider desires to grant any such security interest or grant such collateral assignment, Customer shall execute a commercially reasonable form of consent to such financing as may be reasonably required by the secured parties.

- (c) <u>Cooperation with Tax Equity Investor</u>. If any Person proposes to make an investment in Provider or any of Provider's Affiliates or any successor or permitted assignee of Provider and, as a result of such investment, such Person would become a Tax Equity Investor, upon receipt of a written request from Provider or any such Person, Customer shall negotiate, execute, or arrange for the delivery of such certificates, opinions and other documents as may be reasonably necessary at Provider's expense in order for Provider to consummate the investment by such Person in Provider or any of Provider's Affiliates or any successor or permitted assignee of Provider or any of Provider's Affiliates. Provider shall reimburse, or shall cause the Tax Equity Investor to reimburse, Customer for the incremental, direct expenses (including the reasonable fees and expenses of counsel) incurred by Customer in the preparation, negotiation, execution and/or delivery of any documents requested by Provider or the Tax Equity Investor, and provided by Customer, pursuant to this Section 32.
  - (d) The following definitions shall apply for purposes of this Section 32:
- (i) "Affiliate" means for any specific Person, any other Person directly or indirectly controlling or controlled by or under common control with such specified Person. For purposes of this definition, "control" when used with respect to any entity means the power to direct the management and policies of such entity, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise. For purposes of this Agreement, it is assumed that the direct or indirect owner of fifty percent (50%) or more of the outstanding stock or other equity interest of a Person has "control" of such Person; and the terms "controlling" and "controlled" have meanings correlative to the foregoing.
- (ii) "Change of Control" means for any specific Person any transaction or series of related transactions, which if consummated, would result in such Person being an Affiliate of another ultimate parent entity immediately after such transaction.

- (iii) "Financing Documents" means the documents associated with any Tax Equity Financing and the loan and credit agreements, notes, bonds, indentures, security agreements, lease financing agreements, mortgages, deeds of trust, interest rate exchanges, swap agreements and other documents relating to the development, bridge, construction or permanent debt financing for the System, including any credit enhancement, credit support, working capital financing, or refinancing documents, and any and all amendments, modifications, or supplements to the foregoing that may be entered into from time to time at the discretion of Provider in connection with development, construction, ownership, leasing, operation or maintenance of the System.
- (iv) "*Person*" means any natural person, corporation, limited liability company, general partnership, limited partnership, proprietorship, other business organization, trust, union, association, or government entity.
- (v) "*Project Lender*" means any Person or successors in interest or assignees providing direct or indirect development, bridge, construction, permanent debt financing, Tax Equity Financing, refinancing or extending credit (including any financing lease) to Provider or Provider's Affiliates, including any Tax Equity Investor.
- (vi) "Tax Equity Financing" means a transaction or series of transactions involving one or more investors seeking a return that is enhanced by Tax credits and/or Tax depreciation (each a "Tax Equity Investor") and generally (i) described in Revenue Procedures 2001-28 (sale-leaseback (with or without "leverage")), 2007-65 (flip partnership) or 2014-12 (flip partnership and master tenant partnership) as those revenue procedures are reasonably applied or analogized to a solar project transaction (as opposed to a wind farm or rehabilitated real estate) or (ii) contemplated by Section 50(d)(5) of the Code, as amended (a pass-through lease).
- (vii) "Taxes" means all foreign and domestic taxes, rates, levies, adders, assessments, surcharges, duties and other fees and charges of any nature, whether currently in effect or adopted during the Term, including but not limited to ad valorem, consumption, excise, franchise, gross receipts, import, export, license, property, sales, stamp, storage, transfer, turnover, use or value-added taxes, payroll, unemployment, and any and all related items of withholding, deficiency, penalty, addition to tax, interest or assessment.

## 33. CONFIDENTIALITY.

(a) <u>Confidential Information</u>. Except as otherwise set forth in this Agreement, neither Party shall publish, disclose, or otherwise divulge any term or condition of this Agreement and, without limitation, any information relating to any transaction or documents exchanged between the Parties in connection with this Agreement (such information, the "Confidential Information") to a third person (other than the Party's employees, affiliates, lenders, counsel, accountants, advisors, or potential assignees (throughout assignment, merger, etc.) who have a need to know such information and have agreed to keep such terms confidential), at any time during and for one (1) year after the expiration or early termination of this Agreement, without the other Party's prior written consent. Each Party shall be entitled to all remedies available at law or in equity (including but not limited to specific performance

and/or injunctive relief) to enforce, or seek relief in connection with, this confidentiality obligation.

- (b) Non-Confidential. The following shall not be considered Confidential Information, and receiving Party shall not be limited in the use or disclosure of the following information: (a) information that is or becomes part of the public domain through no act or omission of receiving Party; (b) information that demonstrably was known or was in the possession of receiving Party without obligation to maintain confidentiality prior to the Effective Date of this Agreement; (c) information that is subsequently rightly received by receiving Party from a third party who is not bound to maintain such information as confidential; (d) information independently developed by the receiving Party without reference to the Confidential Information received under this Agreement; and/or, (e) information required to be disclosed to meet compliance obligations to regulatory commissions/authorities.
- Party shall either (i) return the Confidential Information, including all copies, or (ii) destroy the Confidential Information, including all copies, and present written assurances of the destruction to disclosing Party. Notwithstanding the foregoing, both Parties acknowledge that Confidential Information transferred and maintained electronically (including e-mails) may be automatically archived and stored by receiving Party on electronic devices, magnetic tape, or other media for the purpose of restoring data in the event of a system failure (collectively, "Back-Up Tapes"). Notwithstanding the terms of this Agreement, in no event shall the receiving Party be required to destroy Confidential Information stored on Back-Up Tapes; provided, however, any Confidential Information not returned or destroyed pursuant to this Section shall be kept confidential for the duration of its existence. Furthermore, the Parties agree that receiving party may retain one (1) copy of such Confidential Information in receiving Party's files for audit and compliance purposes for the duration of its existence; provided, however, such Confidential Information shall be kept confidential for the duration of its existence in accordance with the terms of this Agreement.
- (d) Required Disclosures. Notwithstanding the confidentiality requirements set forth herein, a Party may disclose Confidential Information in response to a court order, in connection with any court or regulatory proceeding, or as otherwise required by any requirement of law. Such disclosure shall not terminate the obligations of confidentiality unless the Confidential Information thereafter falls within one of the exclusions specified in this Agreement. To the extent the disclosure of Confidential Information is requested or compelled as set forth above, the receiving Party agrees, if legally permissible, to give disclosing Party reasonable notice of any discovery request or order, subpoena, or other legal process requiring disclosure of any Confidential Information. Such notice by the receiving Party shall give disclosing Party an opportunity, at disclosing Party's discretion and sole cost, to seek a protective order or similar relief. If such protective order or other appropriate remedy is not sought and obtained within at least ten (10) days of receiving Party's notice (or such shorter period specified in the notice if required under applicable law), receiving Party shall disclose only that portion of the Confidential Information that is required or necessary in the opinion of receiving Party's legal counsel; provided, however, receiving Party shall use reasonable efforts to obtain assurances that confidential treatment will be accorded to any Confidential Information so disclosed.

- 34. <u>SUCCESSORS</u>. This Agreement shall extend to and bind the heirs, personal representative, successors and assigns of the Parties hereto.
- 35. <u>SUBMISSION OF AGREEMENT</u>. The submission of this Agreement for examination does not constitute an offer to install the System or perform the Services and this Agreement becomes effective only upon the full execution and delivery of this Agreement by the Parties. If any provision herein is invalid, it shall be considered deleted from this Agreement and shall not invalidate the remaining provisions of this Agreement. Each of the Parties hereto warrants to the other that the person or persons executing this Agreement on behalf of such Party has the full right, power and authority to enter into and execute this Agreement on such Party's behalf and that no consent from any other person or entity is necessary as a condition precedent to the legal effect of this Agreement.
- 36. <u>SURVIVAL</u>. The provisions of the Agreement relating to indemnification from one Party to the other Party shall survive any termination or expiration of this Agreement. Additionally, any provisions of this Agreement which require performance subsequent to the termination or expiration of this Agreement shall also survive such termination or expiration.
- 37. <u>CAPTIONS</u>. The captions contained in this Agreement are inserted for convenience only and are not intended to be part of the Agreement. They shall not affect or be utilized in the construction or interpretation of the Agreement.
- 38. <u>PUBLICITY</u>. Provider and Customer share a common desire to generate favorable publicity regarding the System and their association with it, and agree that they may, from time-to-time, issue press releases regarding the System and that they shall cooperate with each other in connection with the issuance of such releases including, without limitation, completed review of press releases proposed to be issued by the other Party by no later than ten (10) business days after submission by such other Party. Each of Provider and Customer agrees that it shall not issue any press release regarding the System without the prior consent of the other, and each party agrees not to unreasonably withhold or delay any such consent.

#### EXHIBIT G

## **Purchase of System by Customer**

If Customer exercises its purchase option provided in Section 25 above, the purchase price for such System shall be the greater of (i) \$\_\_\_\_\_\_\_, or (ii) the Fair Market Value of the System as provided below (such price, the "Good Standing Purchase Price").

The Fair Market Value of the System will be the value determined by the mutual agreement of the Parties within the 30 days immediately following the Customer's delivery of notice of its intent to purchase the System pursuant to Section 25. If the Parties cannot agree on the Fair Market Value within such period of time, then the Parties shall select a nationally recognized independent appraiser with experience and expertise in the U.S. commercial and industrial solar energy industry to value the System. If the Parties cannot agree on the selection of such an appraiser, then each Party shall promptly propose an appraiser and direct those appraisers to promptly select the appraiser for this process. If the two proposed appraisers cannot agree on an independent appraiser within a reasonable period, then either Party may apply to the American Arbitration Association to make such an appointment. Such appraiser shall act reasonably, promptly, and in good faith to determine the Fair Market Value, and shall set forth such determination in a written opinion delivered to the Parties. The valuation made by the appraiser shall be the value that would be paid in an arm's length, free market transaction, for cash, between an informed, willing seller and an informed, willing buyer, neither of whom is under compulsion to complete the transaction, taking into account, among other things, the market price of the energy and environmental attributes generated by the System, the age, condition and performance of the System and advances in solar technology, and any other factors consistent with industry standards at such time for appraising solar photovoltaic generation facilities similar to the System; provided, that installed equipment shall be valued on an installed basis, and shall not be valued as scrap if it is functioning and in good condition. The valuation made by the appraiser shall be binding on the Parties in the absence of fraud or manifest error. The cost of the appraisal shall be borne by the Parties equally.

#### **EXHIBIT H**

## **Production Guaranty**

- (v) any system failure or lost production not caused by a System defect;
- (vi) a power or voltage surge, including a grid supply voltage outside of the standard range specified by the local utility or the System specifications or as a result of a local power outage or curtailment.

- 1. <u>Guaranty; Limitation of Liability</u>. Subject to any rights, setoffs, counterclaims and any other defenses that the Guarantor expressly reserves to itself under this Guaranty, the Guarantor absolutely and unconditionally guarantees the timely payment of the Obligor's payment obligations under the Agreement (the "<u>Guaranteed Obligations</u>"); <u>provided, however</u>, that the Guarantor's aggregate liability hereunder shall not exceed [amount] U. S. Dollars (U.S. [\$xx,xxx,xxx]).

Subject to the other terms of this Guaranty, the liability of the Guarantor under this Guaranty is limited to payments expressly required to be made under the Agreement, and except as specifically provided therein, the Guarantor shall not be liable for or required to pay any consequential or indirect loss (including but not limited to loss of profits), exemplary damages, punitive damages, special damages, or any other damages or costs.

- 2. <u>Effect of Amendments</u>. The Guarantor agrees that the Beneficiary and the Obligor may modify, amend and supplement the Agreement and that the Beneficiary may delay or extend the date on which any payment must be made pursuant to the Agreement or delay or extend the date on which any act must be performed by the Obligor thereunder, all without notice to or further assent by the Guarantor, who shall remain bound by this Guaranty, notwithstanding any such act by the Beneficiary.
- 3. <u>Waiver of Rights</u>. The Guarantor expressly waives (i) protest, (ii) notice of acceptance of this Guaranty by the Beneficiary, and (iii) demand for payment of any of the Guaranteed Obligations.
- 4. <u>Reservation of Defenses</u>. Without limiting the Guarantor's own defenses and rights hereunder, the Guarantor reserves to itself all rights, setoffs, counterclaims and other defenses that the Obligor may have to payment of all or any portion of the Guaranteed Obligations except defenses arising

from the bankruptcy, insolvency, dissolution or liquidation of the Obligor and other defenses expressly waived in this Guaranty.

- 5. <u>Settlements Conditional</u>. This guaranty shall remain in full force and effect or shall be reinstated (as the case may be) if at any time any monies paid to the Beneficiary in reduction of the indebtedness of the Obligor under the Agreement have to be repaid by the Beneficiary by virtue of any provision or enactment relating to bankruptcy, insolvency or liquidation for the time being in force, and the liability of the Guarantor under this Guaranty shall be computed as if such monies had never been paid to the Beneficiary
- 6. <u>Notice</u>. The Beneficiary will provide written notice to the Guarantor if the Obligor defaults under the Agreement.
- 7. <u>Primary Liability of the Guarantor</u>. The Guarantor agrees that the Beneficiary may enforce this Guaranty without the necessity at any time of resorting to or exhausting any other security or collateral or any other remedy. This is a continuing Guaranty of payment and not merely of collection.
- 8. <u>Representations and Warranties.</u> The Guarantor represents and warrants to the Beneficiary as of the date hereof that:
  - a. The Guarantor is duly organized, validly existing and in good standing under the laws of the jurisdiction of its incorporation and has full power and legal right to execute and deliver this Guaranty and to perform the provisions of this Guaranty on its part to be performed;
  - b. The execution, delivery and performance of this Guaranty by the Guarantor have been and remain duly authorized by all necessary corporate action and do not contravene any provision of its certificate of incorporation or by-laws or any law, regulation or contractual restriction binding on it or its assets:
  - c. All consents, authorizations, approvals, registrations and declarations required for the due execution, delivery and performance of this Guaranty have been obtained from or, as the case may be, filed with the relevant governmental authorities having jurisdiction and remain in full force and effect, and all conditions thereof have been duly complied with and no other action by, and no notice to or filing with, any governmental authority having jurisdiction is required for such execution, delivery or performance; and
  - This Guaranty constitutes the legal, valid and binding obligation of the Guarantor enforceable against it in accordance with its

terms, except as enforcement hereof may be limited by applicable bankruptcy, insolvency, reorganization or other similar laws affecting the enforcement of creditors' rights or by general equity principles.

- 9. Nature of Guaranty. The Guarantor hereby agrees that its obligations hereunder shall be unconditional irrespective of the impossibility or illegality of performance by the Obligor under the Agreement; the absence of any action to enforce the Agreement; any waiver or consent by Beneficiary concerning any provisions of the Agreement; the rendering of any judgment against the Obligor or any action to enforce the same; any failure by Beneficiary to take any steps necessary to preserve its rights to any security or collateral for the Guaranteed Obligations; the release of all or any portion of any collateral by Beneficiary; or any failure by Beneficiary to perfect or to keep perfected its security interest or lien in any portion of any collateral.
- 10. <u>Subrogation.</u> The Guarantor will not exercise any rights that it may acquire by way of subrogation until all Guaranteed Obligations shall have been paid in full. Subject to the foregoing, upon payment of all such Guaranteed Obligations, the Guarantor shall be subrogated to the rights of Beneficiary against the Obligor, and Beneficiary agrees to take at the Guarantor's expense such steps as the Guarantor may reasonably request to implement such subrogation.
- 11. <u>Term of Guaranty</u>. This Guaranty shall remain in full force and effect until the later of (i) such time as all the Guaranteed Obligations have been discharged, and (ii) [date] (the "Expiration Date").
- 12. <u>Governing Law</u>. This Guaranty shall be governed by and construed in accordance with the internal laws of the State of New York without giving effect to principles of conflicts of law.
