#### SUBMISSION OF AGREED PROCEDURAL SCHEDULE

Duke Energy Indiana, LLC ("Duke Energy Indiana"), by counsel, respectfully submits the following agreed procedural schedule on behalf of Duke Energy Indiana, the Indiana Office of Utility Consumer Counselor ("OUCC"), the Citizens Action Coalition of Indiana, Inc., and Walmart Inc. (together, the "Parties"), and request the Commission approve this procedural schedule. In support of this schedule, Duke Energy Indiana provides the following:

Duke Energy Indiana filed its Petition and case-in-chief testimony on September
24, 2018.

2. Duke Energy Indiana and the OUCC have reached an agreement on a procedural schedule as outlined below:

- November 21, 2018 OUCC and any intervenors shall file their direct testimony and exhibits constituting their cases-in-chief.
- December 6, 2018 Duke Energy Indiana shall file its rebuttal testimony, if needed.
- Evidentiary Hearing to be held the week of January 21, 2019.

3. The Parties have agreed that any response or objection to a discovery request shall be made within ten (10) calendar days of the receipt of such request. Any discovery requests served after December 6, 2018 shall be responded to or objected to within five (5) business days.

4. The Parties agree to electronic service of discovery and filings in this proceeding.

WHEREFORE, Duke Energy Indiana, on behalf of itself and the OUCC, requests that the Commission establish a procedural schedule consistent with this submission.
