### DIGEST OF INTRODUCED BILL

### Citations Affected: IC 8-1-2-101.2.

**Synopsis:** Local unit power to prohibit utility connection. Provides that the legislative body of a city or town or a county executive does not have the power to prohibit: (1) a public utility or department of public utilities from furnishing utility service to a utility customer; or (2) a customer of a public utility or department of public utilities from purchasing, using, or connecting or reconnecting to a utility service; based on the energy source of the utility service. Provides that any code, ordinance, land use regulation, or general or specific plan provision adopted by the legislative body of a city or town or a county executive must preserve the ability of an owner of private property to use the utility service of a utility service.

Effective: January 1, 2021 (retroactive).
