### INDIANA DISTRIBUTED ENERGY ALLIANCE PETITION TO INTERVENE

The Indiana Distributed Energy Alliance ("IndianaDG"), by Counsel, files this Petition to Intervene in the above captioned proceeding pursuant to 170 I.A.C. 1-1.1-11 and in support thereof state as follows:

- 1. IndianaDG is an Indiana Nonprofit Corporation that through advocacy, education, and partnership seeks to promote and grow distributed generation and renewable energy in Indiana, thereby promoting economic development, improving the environment and benefiting electric utility ratepayers through Indiana alternative energy sources.
- 2. IndianaDG has members who are in the business of selling; installing and developing distributed generation in Duke Energy Indiana's ("Duke") service territory and elsewhere in Indiana. Some of the members own Indiana distributed and renewable energy generation in Duke Energy's service territory and elsewhere. IndianaDG members include those listed on attached Appendix A.
- 3. IndianaDG members have substantial business, economic and societal interest in the price Duke and other Indiana Electric utilities pay customers in exchange

for receipt of customers' excess distributed generation energy. Members' current and future business operations will be impacted by the price paid for and metering of excess customer owned distributed generation.

- 4. Indiana's growth of renewable generation and Hoosiers' ability to afford the capital cost of customer owned distributed generation hinges in large part upon the price the customer will receive for their excess distributed generation "EDG" and the manner in which the EDG is metered. As such, IndianaDG members have substantial economic; business and social interest in and will be impacted by Duke's proposals in this Cause.
- 5. Similarly some of the IndianaDG members are customers of Duke and own distributed generation facilities connected to Duke's electric system. They thereby also have substantial interest in Duke's proposals in this Cause.
- 6. IndianaDG believes Duke's electric customers' willingness and ability to invest in their own renewable distributed generation facilities will be negatively impacted by Duke's excess generation rate and metering proposals in this Cause.
- 7. As vendors, installers, and owners of Indiana distributed generation equipment, IndianaDG members will be financially impacted by the proposals in this Cause. The sales of distributed generation equipment and installation along with the IndianaDG businesses and employees who perform those functions in Duke's service area will be impacted by the proposals in this Cause and in turn so well Indiana's economic development opportunities.
- 8. IndianaDG members have specialized, actual business knowledge, ability and hands on experience in retail and commercial utility customers' interests in the

requirements for distributed generation and the compensation received for EDG.

IndianaDG members believe this knowledge and experience will be useful to the

Commission, the other Parties, and to public service in administering this Cause.

9. To protect their broad interests and economic development Indiana DG

and its members need to stay informed of, participate in, and address matters to be

considered and determined by the Commission in this Cause.

10. The interests of IndianaDG and its members are not and will not be

adequately represented by any other party to this proceeding.

11. This intervention will not unduly broaden issues or result in unreasonable

delay and is made more than five days before any scheduled evidentiary hearing.

12. Pursuant to 170 IAC 1-1.1-11(b)(3), IndianaDG requests the Commission

ensure that rates and metering for excess generation to be addressed in this Cause fairly

represent avoided costs and comply with the requirements of state and federal laws and

regulations.

WHEREFORE, given its substantial interests in this Cause IndianaDG

respectfully requests to be made a party in this proceeding and for all other relief

appropriate in the premises.
